

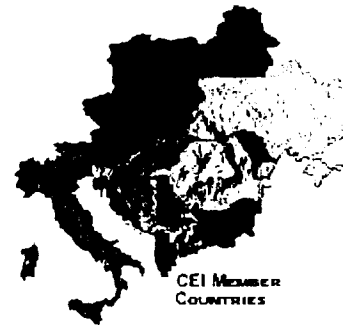

### FORUM SUBJECTS

- ◆ Country presentations: investment conditions and project opportunities

### SPEAKERS AND PRESENTATIONS AT THE FORUM

- ◆ **Seminars** for specialised audiences
- ◆ **Round tables** on current issues: Ministers of Economy, Chambers of Commerce, Investment Promotion Agencies, Italian Institute for Foreign Trade (ICE) and UN/ECE, plus presentations by exhibitors.
- ◆ **Interest groups** for fewer participants interested in developing co-operation arrangements and specific initiatives (CEI Working Groups, INFORMEST, MIGA, OECD, etc.)

### NETWORKING

The CEI provides facilities for business networking before, during, and after the Forum:

- ◆ **Project Centre** and project database also with poster displays, to facilitate networking and matching of supply and demand
- ◆ **Bilateral meetings** between participants and government officials, financial institutions, international organisations, consultants, etc.
- ◆ **Link with top CEI political meetings** (Summit of Prime Ministers, meetings of Ministers of Foreign Affairs and of Ministers of economic sectors)
- ◆ **Social events** and ample opportunities for networking (also using the CEI database and "networking form"). In one reception, participants will be able to meet Prime Ministers, Ministers of Foreign Affairs, and Economy Ministers of CEI countries.
