



PROJECT SUMMARY

1. Background/Framework:

The river Danube connects the Central-Europe with the Black Sea. It flows through 9 European countries; four capitals are located by the Danube. This indicates the strong importance of the river in common economic, historical and cultural terms. DONAUHANSE is an INTERREG III-B programme and aims to create a "common wealth for the participating cities and regions.

2. Objectives:

Set-up of a common platform/network for:

- Problem solving (such as environmental vs. economic activities, financing and funding,...)
- Development of projects and proposals ready for implementation
- Creation of networks of cities with aim to advance their regional and spatial development through co-operative action in the fields of economy, urban planning, trade and transport as well as tourism.
- Designing of awareness raising for urban development strategies leading to the identification and usage of regional potentials within the cities and the Danube Space as a whole.
- Assessing and advancing of the potentials of the Danube cities by making use
 of their particular situation on the river and of their economic strengths, but
 also of their cultural and touristic potential.

3. Organisation:

A workshop held by the co-financing partners (City of Vienna, Austrian Federal Ministry for Economics and Labour, Economic Region Danube Cities, Danube Lower Austria Tourism Company) in November, suggested that DONAUHANSE should establish four working groups with following topics:

- 1) Cultural issues
- 2) Tourism
- 3) Ports
- 4) Economy

During the kick-off conference four workshops according to the defined topics will be held to discuss more details.

4. Goals for the kick-off conference within the working groups:

The four topics of the working groups will be organised in parallel workshops. All participants should provide their written ideas and inputs in advance.

At least two sessions of the workshops should be held.
